GRANTS TO NONPROFITS

- You make a gift to the community foundation—you can give cash, appreciated stocks, real estate or other assets.
- We set up a scholarship fund in your name, in the name of your family or business or in honor of any person or organization you choose.
- You may receive tax benefits in the year your gift is made.
- Our professional program staff helps you to determine eligibility requirements for the scholarship you establish—whether they are based on a student’s field of study, academic achievements, extracurricular activities, financial need, background or geography.
- We handle all the administrative details—and award scholarships to deserving students in the name of the fund you establish.

A couple of years into a comfortable retirement, John and Rose DiAngelo, both former teachers, realized how much they missed making a difference in the lives of students. “For both of us, education was not only a profession—it was a calling,” John DiAngelo said.

Looking for a way to stay involved, the DiAngelos started a scholarship with their community foundation.
