

Memorial Gift Acceptance Policy Memorandum of Understanding and Memorial Gift Direction Form

When a loved one dies, keeping their memory alive through memorial gifts is one way of honoring their life, finding comfort, and preserving their memory. The Branch County Community Foundation is honored to accept memorial contributions as a fitting tribute to those who have enriched our lives and our community.

To assure that we have a common understanding with the family and friends of the loved one of how memorial gifts are best used, the Community Foundation has developed this Memorial Gift Acceptance Policy and the Memorandum of Understanding and Memorial Gift Direction Form.

Memorial Gift Acceptance Policy

Gift Acceptance

Memorial gifts will be accepted in accordance to our general Gift Acceptance Policy. In general, the Community Foundation will accept gifts in the form of checks, cash, or cash equivalents and marketable securities. (A complete copy of Policy is available upon request.)

Designation

A gift in memory of a friend or loved one can be made to *any existing fund or designated area* of interest at the Branch County Community Foundation. The Forever Fund will be the designated fund for those families who want to designate memorial gifts to help our community and the Catalyst Fund will be the designated fund for those families who want to designate memorial gifts for post-secondary scholarships. Gift Donation Form

To assure proper recognition of the loved one and appropriate designation for the gift, the Community Foundation's *Memorial Gift Donation Form* should be included with all gifts whenever possible. The Memorial Gift Donation Form is included with this Memorandum, is available on our website at BrCoFoundation.org, and if requested, can be printed and provided at the location where the loved one will be honored.
